They should apply in the prescribed application form which is available in the University website: [www.tvu.edu.in](http://www.tvu.edu.in) The downloadable application along with the necessary fee alone shall be considered. Applications from the educational agencies/trusts for starting new colleges shall be submitted along with all documents as mentioned in the application. Applications without enclosures will not be considered.

Application submitted by the Management of Colleges not in the prescribed format will be summarily rejected. The request of the existing colleges seeking further affiliation and by Educational Trusts even with the approval of the State Government for starting new colleges will not be considered after the due date.

Educational Trusts for starting new colleges/Existing Colleges which had applied in the prescribed form earlier but not granted affiliation by the University should also apply afresh application for affiliation for the academic year 2019-2020.

The last date for submission of applications will be 31<sup>st</sup> October 2018. The submission of belated applications will be received from 1<sup>st</sup> November to 10<sup>th</sup> December 2018 with penalty.

The filled in application together with all the enclosures along with the remittance of fees challan for Rs.18,000/- for application fees and remittance of fees challan for Rs.24,000/- for each course/additional section towards processing fees should reach the University on or before 31.10.2018.

The application for affiliation received from you without any necessary documents, signature, incomplete application and necessary application fees and processing fees will be rejected.

Further I am by direction to inform you that the belated submission of applications for affiliation with application fees and necessary enclosures for the academic year 2019-2020 will be accepted from 01.11.2018 to 10.12.2018 till 5.45 pm only with the following penal fees.

- Rs.18,000/- to the existing colleges for starting new courses/additional section(s) in UG courses /permanent affiliation/research courses.
- Rs.36,000/- to the educational trusts for starting new Arts and Science colleges / institutions.

Fees should be remitted directly to the University Account maintained in favour of The Registrar in IOB, Thiruvalluvar University Branch, Serkkadu, Vellore-632 115 (IFSC Code No. of IOB TVU Branch:IOBA0002484), (MICR Code No.632020014), (SB Account No.248401000000001) by way of RTGS/NEFT and CBS mode. The college should mention the UTR No. in the remittance challan. Only on receipt of the above, further action will be taken in this regard. Submit the Remittance Challan to the University. Fees exempted for Government Colleges.
